# I. Call to Order

Two were received back. Bids were opened at 1:00 p.m. on Friday, February 28, 2008, and then evaluated independently by two reviewers. The Board received summaries and the "Request for Quotes Evaluation & Recommendation Report" and "Score Sheet" prior to the teleconference.

After review of reports and discussion, the Chair called for a motion and vote from the Board.

Upon motion by Frazier, seconded by McCormick, the Board unanimously agreed to enter into contract with ProsonlTech for development of licensing system, with details of project work plan to be jointly developed with Executive Director, Cornerstone consultant, and Board attorney, and the contract for services to be written by Board attorney.

Upon motion by Frazier, seconded by Carmichael, and unanimously passed, the meeting was adjourned at approximately 12:25 p.m.
