I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board"), held in the Board office at Suite 402 of the Robert E. Lee Building located at 239 North Lamar Street in Jackson, Mississippi, was called to order at 9:10 a.m. by Dr. Walter Frazier, Chair ("Chair") on May 21, 2015. A roll call of members was taken and a quorum was present.

II. Board Operations

A. Financial Matters

1. Financial Report

The Board reviewed Routine Expenditures and Encumbrances to FY2016 Budget as presented by Cornerstone Consulting representative Alice Gorman.

2. Outstanding Invoices for Payment

The Board reviewed outstanding invoices submitted for payment by Cornerstone Consulting, Inc., in the "Outstanding Invoices for Payment" Report.

3. FY17 Budget & Process

Ms. Gorman gave a financial report on the 2015 budget and an explanation on the budget submission. In July, work will begin on the FY17 budget that is due August 1. Gorman explained that a state-wide strategic plan serves as the guideline for all state agency budgets and plans. Per Ms. Gorman, all state budgets focus on accountability.

4. Travel Vouchers

Dr. Frazier tabled submission of travel vouchers until after the Administrative Hearing.

III. Old Business

A. Rules and Regulations

1. Education Requirement

Due to time constraints and the Administrative Hearing scheduled at 1:00 p.m. on May 21, it was decided by the Chair, to table discussion of Rules and Regulations - Education Requirement.

2. Final Version

The Chair called for a motion to accept the Rules and Regulations in final form up to this point (May 21) which included one edit made to Section 4.2.a as follows: "...or having earned a Doctoral or Educational Specialist primarily in counseling, guidance, or related counseling field which meets similar standards as specified above."

Dr. Waller suggested that, future revisions be made as needed.

Upon motion by McCormick, seconded by Williams, the Board unanimously agreed to accept the current Rules and Regulations.

VI. New Business

A. Record Keeping for MS LPC

After some discussion on length of time for MS LPC to maintain client files, the Chair tabled further discussion until the Chair and the Executive Director could look to other health professional Boards and other state counseling boards to their record retention policies.

B. MS LPC Board Vacancies

Dr. Juawice McCormick announced that she would be moving to Hattiesburg during the summer of 2015 to accept a faculty position at the University of Southern Mississippi. Dr. McCormick's new position in USM's School Counseling Department of Education will begin in August 1, 2015.

Waller suggested the Mississippi Counseling be notified of pending vacancy of District II, McCormick, in August, and District I, Waller, in June 2016. Appointments must be LPC practitioners primarily engaged in private or institutional practice.

C. <u>Supervision Reporting Log Update</u>

Version #4 of the Supervision Reporting Log was reviewed. Dr. Frazier called for a motion to approve the log and place it on the website of the Mississippi State Board of Examiners for Licensed Professional Counselors and to make available for online reporting log.

Upon motion by Waller, seconded by McCormick, the Board unanimously agreed to accept the version #4 of the Supervision Reporting Log and make available to supervisees and supervisors.

D. 2016 Legislative Agenda

The 2016 Legislative Agenda was tabled by Dr. Frazier for proper language and further review. The Board directed the attorney to review previous Board attorney's files and Department of Public Safety to determine authority for background check and national fingerprint background checks without opening Board's statutes.

E. Board Meeting & Hearing Dates

The Board discussed and agreed to change the August meeting to the fourth Thursday, August 27, 2015.

F. Mississippi Counseling Association (MCA) Conference

Tentative plans for the LPC Board to present a content session at the Mississippi Counseling Association's annual fall conference in November are being investigated. Dr. Frazier will check with MCA about the possibility of a Board presentation again this year.

G. Minutes Approval

Minutes from the April 16, 2015, Board meeting were reviewed. The Chair called for a motion to approve the April 16, 2015, minutes. Upon motion by Dr. Waller, seconded by Dr. McCormick, the Board unanimously agreed to approve the April 16, 2015, minutes.

Minutes from the April 29, 2015, Special Called Board Teleconference were reviewed. The Chair called for a motion to approve the April 29, 2015, minutes as amended. Upon motion by Dr. McCormick, seconded by Dr. Williams, the Board unanimously agreed to approve the April 16, 2015, minutes as amended.
