I. Call to Order

The Regular Board Meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board"), held in the Board office at Suite 402 of the Robert E. Lee Building located at 239 North Lamar Street in Jackson, Mississippi, was called to order at 9:38 a.m. by Dr. Walter Fraizier, Chair ("Chair") on August 27, 2015. A roll call of members was taken and a quorum was present.

II. Board Operations

A. Minutes Approval

Minutes for the May and June Board meetings were reviewed. Upon motion by McCormick, seconded by Waller, the Board unanimously agreed to accept the May 21-22, 2015, Regular Board Meeting minutes as amended. Upon motion by Waller, seconded by Williams, the Board unanimously agreed to accept the June 18-19, 2015, Special Called Board meeting minutes and the June 19, 2015, Regular Board Meeting minutes as written.

B. Financial Matters

1. Financial Report

Alice Gorman with Cornerstone Consulting, Inc. was unable to provide up to date budget information but relayed that the budget was currently in good standing.

2. AASCB

AASCB membership and conference registration fees were presented and considered. Upon motion by Waller, seconded by McCormick, the Board unanimously agreed to pay the membership fee of \$800 to AASCB for FY 2015-2016 but to postpone further decisions as related to the conference.

3. Travel Vouchers

Upon motion by Williams, seconded by McCormick, the Board unanimously agreed to approve travel vouchers in the amount of \$562.51.

III. New Business

A. October Board Meeting Date

The October meeting date was rescheduled to October 22, 2015.

B. Rules and Regulations Clarifications

1. <u>Rule 4.2.</u>

Upon motion by Carmichael, seconded by Waller, the Board unanimously agreed to submit Emergency Rule and a Proposed Action Rule to revise Rule 4.2. "Education Requirements" for clarification by moving the paragraph beginning with "Effective 2017" under section "4.2.A." and to change the statement in 4.2.B.12. by deleting the language beginning with "NOTE" and through the end of the paragraph.

2. <u>Rule 4.3.A.(2)</u>

No other motions were made but additional clarifications were presented.

3. <u>Rule 4.3.B.</u>

No other motions were made but additional clarifications were presented.

- C. <u>AASCB 5-Year Plan for Portability</u> AASCB portability plan was reviewed and tabled.

D. LPC-Supervisor Performance Evaluations and Training

LPC-Supervisor performance evaluations were discussed for both the supervisor and supervisee. Mordecai to discuss options of online reporting with the website developer. McCormick to review other States' evaluations.

E. Board Appointments

The Board attorney was asked to seek option from the Attorney General regarding Board appointments and to render results by November MCA meeting.

The Chair reconvened the Board meeting at 12:20 p.m.
