I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:05 a.m. by Dr. Richard Strebeck, Chair ("Chair") on Friday January 20, 2023. The Board meeting was held at Robert E. Lee Building, 239 North Lamar Street, Suite 402 Jackson, MS 39201. A roll call of Board members was taken, and a quorum was present.

II. Motion for Continuance

The Board considered a Motion for Continuance for Administrative Hearing (2022-28). Dr. Sallis motioned to approve the continuance motion, seconded by Dr. Etheridge. The motion carried 5-0. The hearing was rescheduled for March 10, 2023.

III. Lorri Savell

In accordance with the Board's Rules and Regulations, Ms. Savell addressed the Board regarding her application for licensure.

IV. Board Operations

A. Officer Elections

In compliance with Rule 3.1.C.4, the Board held officer elections as follows:

- a. Dr. Sallis was nominated by Dr. Windham, seconded by Dr. Strebeck, for chair. No other Board members were nominated. Dr. Sallis was elected Chair by a vote of 4-0-1.
- b. Dr. Windham was nominated by Dr. Etheridge, seconded by Mr. Boose, for Vice-Chair. No other Board members were nominated. Dr. Windham was elected Vice-Chair by a vote of 4-0-1.

c. Dr. Strebeck was nominated by Dr. Etheridge, seconded by Dr. Sallis, for Secretary. No other Board members were nominated. Dr. Strebeck was elected Secretary by a vote of 4-0-1.

B. Minutes

- a. October 4, 2022 After reviewing the October 4, 2022 minutes, Dr. Etheridge motioned, Dr. Sallis seconded, to approve the minutes as written. The motion carried with a vote of 5-0.
- b. October 31, 2022 After reviewing the October 31, 2022 minutes, Dr. Etheridge motioned, Dr. Sallis seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.
- c. <u>November 10, 2022</u> After reviewing the November 10, 2022 minutes, Dr. Etheridge motioned, Dr. Sallis seconded, to approve the minutes as amended. The motion carried with a vote of 5-0.

V. Financial Matters

- A. Financial Report -The Board reviewed financial statement for November and December 2022.
- B. <u>FY 2024 Budget</u> FY 2024, July 1, 2023 through June 30, 2024, recommended budget from the Legislative Budget Office is at level funding plus \$800+ for anticipated payroll expenses.
- C. <u>Board Travel</u> Dr. Etheridge motioned, seconded by Mr. Boose, to approve travel expenses not covered by the Counseling Compact for Ms. Mordecai to attend the Counseling Compact Commission Meeting October 25-26, 2022, in Washington D.C. The motioned carried with the vote of 5-0.

VI. Old Business

- A. <u>AASCB Conference</u> Dr. Windham motioned, seconded by Dr. Etheridge, that the Board pay for Ms. Mordecai's registration and travel expenses and the registration fees for two Board members to attend the American Association of State Counseling Boards in New Orleans, Louisiana, on February 7-9. The motion carried with a vote of 5-0.
- B. <u>Pass/Fail Jurisprudence Exam</u> Ms. Mordecai updated the Board on the implementation of the Pass/Fail Jurisprudence Exam.
- C. Strategic Plan The Board reviewed the Strategic Plan.
 - a. The Board will update the No Fail Jurisprudence exam required for license renewals.
 - b. Dr. Etheridge motioned, seconded by Mr. Boose, to authorize spending up to \$15,000 to redesign the Board's website. The motion carried with a vote of 5-0.

CLOSED DETERMINATION/EXECUTIVE SESSION

Upon motion made by Dr. Etheridge with a second by Mr. Boose, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a vote of 5-0.

In the determination session, Dr. Etheridge motioned, with a second by Dr. Sallis, that the Board had reason to go into Executive Session for the purpose of reviewing applications governing the practice of professional counselors, complaints, and Board requests, which deliberation and consideration could lead to litigation, and/or an appeal of a Board order. The motion carried with a vote of 5-0.
