## I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:05 a.m. by Dr. Kimberly Sallis, Chair ("Chair") on Friday March 10, 2023. The Board meeting was held at Robert E. Lee Building, 239 North Lamar Street, Suite 402 Jackson, MS 39201. A roll call of Board members was taken, and a quorum was present.

#### **II.** Motions for Continuance

The Board considered a Motion for Continuance for Administrative Hearing (2022-28). Dr. Strebeck motioned to approve the continuance motion, seconded by Mr. Boose. The motion carried 4-0. The hearing was rescheduled for May 5, 2023.

The Board considered a Motion for Continuance for Administrative Hearing (2022-24). Mr. Boose motioned to approve the continuance motion, seconded by Dr. Strebeck. The motion carried 4-0. The hearing was rescheduled for May 5, 2023.

#### **III.** Board Operations

A. After reviewing the January 20, 2023 minutes, Dr. Windham motioned, Mr. Boose seconded, to approve the minutes as amended. The motion carried with a vote of 4-0.

B. Dr. Sallis motioned, seconded by Dr. Sallis, that the Board shall adhere to Rule 4.1.H.4. Only completed applications that are submitted ten (10) business days before a Regularly Scheduled Board meeting will be considered for review at that meeting. The motion carried 4-0.

#### **IV.** Financial Matters

- A. Dr. Strebeck motioned, seconded by Mr. Boose, to approve travel expenses for the March 10, 2023 Board Meeting. The motion carried 4-0.
- B. Dr. Strebeck motioned, seconded by Mr. Boose, to approve payment for Dr. Windham's travel expense to attend the AASCB meeting in New Orleans because attending virtually was not allowed, which was a change in the conference format. The motion carried 4-0.
- C. The Board reviewed financial statement for January 2023.
- D. Dr. Windham updated the Board regarding the AASBC meeting.
- E. Dr. Windham motioned, seconded by Mr. Boose, to authorize the purchase and use of an LPC Board cellphone for the Executive Director to use for LPC Board business in accordance with the State of Mississippi policies and procedures. Motion carried with a vote of 4-0.
- F. The Board will present at the F. E. Woodall Conference at Delta State University. Dr. Windham motioned, seconded by Mr. Boose, to approve travel expenses for Board members with accepted proposals to present at the F. E. Woodall conference on April 14, 2023. Motion carried with a vote of 4-0.
- G. Mr. Boose motioned, seconded by Dr. Windham, for the Board to approve the Test Administration Service contract with NBCC as revised. The motion carried with a vote of 4-0. In reference to Rule 4.3.C, the NCE/NCMHCE will be administered to any licensure candidate who has passed the Mississippi State Pass/Fail jurisprudence examination and registers for testing, without any prior review or approval by the State Board or NBCC.

## CLOSED DETERMINATION/EXECUTIVE SESSION – under Miss Code Ann § 25-41-7(b) & (d) / Miss, Code Ann § 73-52-1 (1) & (2)

Upon motion made by Dr. Strebeck with a second by Mr. Boose, the Board voted to go into a closed determination session to establish the need for an Executive Session. The motion carried with a vote of 4-0.

In the determination session, Dr. Windham motioned, with a second by Mr. Boose, that the Board had reason to go into Executive Session for the purpose of reviewing applications governing the practice of professional counselors, complaints, and Board requests, which

deliberation and consideration could lead to litigation, and/or an appeal of a Board order. The motion carried with a vote of 4-0.

- 2. Mr. Boose, motioned, Dr. Sallis seconded, to deny P-0134's request to extend licensure application. P-0134 should complete licensure process by June 30, 2023. The Board will issue a letter outlining her licensure requirements.

#### **RETURN TO REGULAR SESSION**

Upon motion by Mr. Boose, seconded by Dr. Windham, the Board resumed the regular session at 6:00 p.m. The motion carried with a vote of 4-0.

The Board announced the actions taken within the Executive Session. The Board reviewed applications (determinations as listed in Addendum A), potential litigation, and complaints.
