#### IV. <u>Call to Order</u>

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 9:00 a.m. by Dr. Kimberly Sallis, Chair ("Chair") on Friday, August 18, 2023. The Board meeting was held at the Robert E. Lee Building, 239 North Lamar Street, Suite 402. A roll call of Board members was taken, and a quorum was present.

#### V. Administrative Hearing 2023-04

Ms. McKnatt motioned, seconded by Dr. Windham, that at the request of Mr. Phillip Hearn, Ms. Sisco's attorney, grant a continuance to reschedule the hearing. The motioned carried 4-0-1. Dr. Strebeck recused himself.

The Board rescheduled the hearing for Wednesday, October 4, 2023.

#### VI. Board Operations

- A. Ms. Morris conducted the swearing in ceremony for Kerri McKnatt and Dr. Bullock.
- B. After reviewing and making corrections to the July 14, 2023 minutes, Dr. Strebeck motioned, Dr. Windham seconded, to approve the minutes as amended. The motioned passed with a vote of 3-0-2 as follows:

- C. Dr. Windham motioned, seconded by Ms. McKnatt, to purchase board training modules from the American Association for State Counseling Boards (AASCB). The motion carried with a unanimous vote of 5-0.
- D. Dr. Bullock motioned, Dr. Windham seconded, for the Executive Director, Chair, and Dr. Strebeck to attend the AASCB conference January 7-9, 2024, in Tucson, AZ. with expenses paid for the Board. Dr. Strebeck will submit a call for program and present, if selected. The motion carried with a unanimous vote of 5-0.
- E. Dr. Sallis motioned, seconded by Ms. McKnatt to approve the Board registration and travel expenses to attend the Mississippi Counseling Conference Association in November 8-10, 2023.

- Dr. Bullock motioned, seconded by Ms. McKnatt, to approve Ms. Phillip's request to complete her P-٠ LPC with an extension until February 18, 2024. The motion carried with a unanimous vote of 5-0.
- Dr. Windham motioned, seconded by Dr. Bullock, to set Ms. Stapleton's appeal to denial of application • for a show cause hearing on Wednesday, October 4, 2023. The motion carried with a unanimous vote of 5-0.
- Dr. Sallis motioned, seconded by Dr. Strebeck, to accept Ms. Stiles's request to count continuing • education from PESI. The motion carried with a unanimous vote of 5-0.
- Dr. Strebeck motioned, seconded by Dr. Windham, to deny Ms. Fletcher's request for an extension of ٠ time to comply with her Letter of Reprimand. The motion carried with a unanimous vote of 5-0.
- Dr. Sallis motioned, seconded by Dr. Bullock, that based on the information provided in Mr. Harry's predetermination request would not preclude him from seeking licensure. The motion carried with a vote of 4-0-1, Dr. Strebeck abstained.
- Dr. Bullock motioned, Dr. Windham seconded, allowing Dr. Jones to retire her license. The motion carried with a unanimous vote of 5-0.
