I. Call to Order

The Regular Board meeting of the Mississippi State Board of Examiners for Licensed Professional Counselors ("Board") was called to order at 1:36 p.m. by Dr. Kimberly Sallis, Chair ("Chair") on Thursday, November 9, 2023. The Board meeting was held at the White House Hotel, 1230 Beach Blvd, Biloxi, MS 39530. A roll call of Board members was taken, and a quorum was present.

II. Board Operations

A. After reviewing and making corrections to the October 4, 2023 minutes, Dr. Bullock motioned, Ms. McKnatt seconded, to approve the minutes as amended. The motion carried with a unanimous vote of 5-0.

III. Financial

- C. Dr. Strebeck motioned, seconded by Ms. McKnatt, to approve travel for attending the Mississippi Counseling Association Meeting and the Board meeting. The motion carried with a unanimous vote of 5-0.
